ORDINANCE NO. 2015-12

AN ORDINANCE TO APPROVE CURRENT REPLACEMENT PAGES TO THE VILLAGE OF WAITE HILL CODIFIED ORDINANCES, AND DECLARING AN EMERGENCY.

WHEREAS, certain provisions within the Codified Ordinances should be amended to conform with current State law as required by the Ohio Constitution; and

WHEREAS, various ordinances of a general and permanent nature have been passed by Council which should be included in the Codified Ordinances; and
